I am required to complete and annually update a declaration of interests form to register my financial and other interests that could potentially conflict with my CRC role above. I must also ensure that any significant changes are notified to the CRC immediately. I have provided an up-to-date list of my interests below.

- non-financial interests
- interests of those close to me –any financial and non-financial interests of close family members¹ and people living with me that could be thought of as relevant to CRC activity.

I am aware that, in addition to providing this list, I am also required to declare any interests at the start of any CRC meeting where any particular interest conflicts with some or all of the business to be discussed at that meeting. I must also disclose any conflicts that may arise prior or in the course of a CRC Council meeting.

Direct financial interests

Any activity for which I am or have been paid for within the last five years, whether or not the activity relates to the work of the CRC.²
